

# 2008-2009 Community Facilities Committee Meeting Schedule

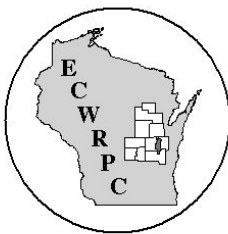
## East Central Wisconsin Regional Planning Commission

The Committee has tentatively scheduled six regular meetings, to be held on the **2<sup>nd</sup> Wednesday of every other month at 1:00 PM**. The meetings are typically held at East Central's offices, however; they may vary depending on the nature of the agenda items. In order to allow staff sufficient time to review and address proposed SSA Plan Amendments, all formal written requests and the required supplemental materials must be submitted appropriately 30 day prior to the meeting date to be considered for the agenda. Unless it is an unusual situation which requires more immediate action, a minimum of two formal action or review items are required to actually convene the meeting.
